OPTION 1: PURCHASE AN ANIMAL

Yes, I would like to purchase an animal. (Please utilize bidder number during Sale.)
Buyers may purchase animals for their own use, just as they would at a regular auction. If you are the highest bidder, and you purchase an animal, a "runner" will bring the sales slip for you to sign. If you would like to keep the animal, you will pay the full purchase price for it. The Market Animal Sale Committee will deliver your animal to the packing plant. You will indicate which packer you prefer when you sign the sales slip. It is then up to you to contact that packer directly for cutting and wrapping instructions. If you do not want to keep the animal, you may "turn it back"; thus meaning you will only pay the difference between the purchase price and the floor price, and the animal will be sent to a Floor Buyer.

OPTION 2: BUYER POOL

If you do not feel you can buy an animal, we accept donations for a buyer pool. We pool all of these donations to purchase the "blue sky" (difference between purchase price and the floor price) on individual animals.

OPTION 3: ADD-ON MONEY TO 4-H & FFA MEMBER'S PROJECT

PAYMENT INFORMATION & TERMS & CONDITIONS

Each bidder must be properly registered (completed Market Animal Sale Buyer Registration Sheet) and have a buyer's number to bid. If any dispute arises between two or more bidders, the Auctioneer may immediately put the animal up for sale again and resell to the highest bidder. The decision of the Auctioneer shall be final and absolute. The Auctioneer reserves the right to reject any and all bids. The record of sale kept by the Auctioneer and Sale Clerk will be taken as final in the event of any dispute. On-site payment will be available before, during, and after the Sale. If your account is not paid in full following the Sale, you will be billed. Cashable checks and/or cash are accepted as forms of payment. Any invoice not paid in full within 30 days of billing date will become delinquent. A delinquency charge of 5% of total bill will be imposed following 30 days, a 7.5% delinquency charge of total bill following 60 days, & a 10% delinquency charge of total bill following 90 days will be imposed if not paid in full. Any account not paid in full within 120 days of the original billing date will be turned over to small claims court. You will be responsible for all charged collection costs, court costs, and any attorney fees incurred, as well as all late charges imposed. You will also lose all purchasing privileges for future 4-H & FFA Market Animal Sales. The Sale Committee coordinates with private packers to offer options to the buyers at the Sale. Buyers who opt to select one of the available Packers enter into a private business contract with the selected Packer. The Sale Committee does not represent or indemnify the Packers in those private contracts.
