

### Special District Information and Candidate Information

#### CANDIDATE FILING FORMS CAN BE FOUND HERE

On odd years, elections are held for Special District seats and City government seats. Candidates must file for their seats or be appointed by the district.

There are many Special Districts in our County. The County works with the District Clerks and City Clerks to process candidate filings.

#### The filing process:

- Candidate obtains form packet
- Candidate completes Declaration page and obtains at least 5 signatures of active eligible voters in the District on the Petition page
- Candidate or District provides Declaration page and <u>original</u> Petition page to Clerk's Office for verification of candidate qualifications and petition signatures
- o (City Candidates only can pay \$40.00 to the City instead of doing the petition)
- Candidate files candidacy paperwork with the City or Special District <u>by the filing</u> <u>deadline</u>

### The filing deadlines:

- o Special District Candidate filing: 8:00 am Aug 18th Aug 29th 5:00 pm
- Write-In for Special District Candidate filing deadline 5:00 pm Sept. 5<sup>th</sup>
- o City Candidate filing window: 8:00 am Aug. 18th Aug. 29th 5:00 pm
- Write-In for City Candidate Filing Deadline 5:00 pm September 5<sup>th</sup>


