

2025 Custer County Voter Information

The Clerk's Office conducts election in Custer County in compliance with the Secretary of State and Idaho Code. We will be happy to help you vote and file for candidacy!

There are no statewide or countywide elections this year, however there is plenty of activity in our local Cities and Special Districts!

2025 Election Dates November 4, 2025

Note: Elections are only held if there are contested positions or if districts choose to ask ballot questions. These elections are only open to voters within the city or district. Some Custer County Voters will not fall into these categories this year.

Absentee Voting Information

Once you are a registered voter, you can vote absentee in any election you are eligible for! Absentee Ballot Requests must be made by the voter in writing or directly through the Secretary of State's online request portal.

Or you can:

The form must be signed by the voter, then it can be returned to the Clerk's Office in these ways:

You can register to vote online at <u>Registering To Vote | Voteldaho.Gov</u>. You can also register in person at the Courthouse or by mail or at the polls on election day!

Note: You will need a valid photo ID and documentation proving (30)+ residency to complete your registration and cast your ballot. Approved proofs of identity and residency can be found here: <u>Voter ID and Registration Requirements</u>

Other Important 2025 Voter Information

You can vote by mail ballot, at our in-person precinct prior to the election, or at the polls on election day.

Pre-Registration Deadlines

There is a short window prior to every election that registration is closed, however during that timeframe you are able to register and vote at the same time in the In-Person Absentee Precinct at the Courthouse <u>or</u> you can wait and register and vote at the polls on election day)

October 24 - deadline prior to the November election

Absentee Ballot by Mail Application Deadlines

October 24 – deadline to request an absentee ballot be mailed to you

<u>In-Person Absentee Voting</u> takes place at the Courthouse, 8 am – 5 pm M-F, up until the Friday before an election.

We begin our in-person voting at the Courthouse as soon as we are ready and the opening date will be announced as soon as possible!

If you live downstream of Watts Bridge you are in the Sunol Precinct and registered voters are automatically mailed a ballot

If you live above the Mackay Reservoir and below Willow Creek Summit you are in the Battleground Precinct and registered voters are automatically mailed a ballot
