#### LIABILITY INSURANCE

ALL groups applying for use of the Custer County Fairgrounds facilities must furnish evidence of liability insurance, naming Custer County as Co-Insurers. A copy of the policy must accompany this application for consideration by the Custer County Fair Board.

The Custer County Fair Board has the right to waive proof of liability insurance for certain events if they deem the event is: 1. Not a high-risk event, 2. No gate admission is charged, and 3. No alcohol is served/sold on the premises.

I/We, the undersigned applicant, does hereby agree that all Custer County Fairgrounds property (tables/chairs) that applicant's group rents/sets-up while using the fairgrounds facilities will be put away. The rented facilities including the outdoor arena, exhibit building (comprising the grass area, cook shack, restrooms), horse stalls, other buildings, and RV spaces will be restored to pre-use conditions. All garbage must be removed from the fairgrounds property within three (3) days. The undersigned agrees that in the event that the Custer County Fairgrounds facilities are not returned to its pre-use condition, the user group will be billed for any labor and parts associated with returning it to its pre-use condition. Any damage beyond reasonable normal wear and tear will be billed accordingly. The undersigned agrees not to assign, lease, or sublet the said Custer County Fairground facilities or property (with prior approval, exceptions can be made for use of the cook shack facilities). The undersigned will abide by all rules and regulations passed or adopted by the Custer County Fair Board for said Custer County Fairgrounds facilities and property.
