

# ELECTION PUBLIC NOTICE

## The Custer County Clerk's Office will be accepting Declarations of Candidacy for County Offices for the Primary Election to be held on May 19, 2026.

Declarations can be filed online at [voteidaho.gov](http://voteidaho.gov) or paper forms are now available in the Clerk's office at the Courthouse or on our website at [custercountyidaho.org](http://custercountyidaho.org) within the Elections Information/Forms page. The forms contain instructions and we are happy to answer any additional questions you may have.

The original completed forms will be accepted at the Clerk's Office at 801 E. Main in Challis from **March 2, 2026 at 8:00 a.m. to March 13, 2026 at 5:00 p.m.** Signatures are verified and certified at the Clerk's Office.

- Partisan Candidates must either obtain 5 registered elector signatures or pay a \$40 filing fee (payable in cash, check or card at time of filing).
- Independent Candidates must file in the same time frame and must obtain 5 signatures.
- Write-in Candidates must file by March 20, 2026 at 5:00 p.m.
- Qualified candidates will appear on the ballot in the Primary Election held on May 19, 2026.
- The winner of the Primary advances to the General Election ballot in November<sup>†</sup>.
- Declarations will be accepted at the Custer County Clerk's Office from March 2 – 13, 2026.
