**NOTICE OF CITY OF CHALLIS
ADOPTING ORDINANCE 525 MUNICIPAL NON-PROPERTY SALES TAX ORDINANCE**

Shall the City of Challis, Idaho, adopt Ordinance No. 525 (Municipal Non-Property Sales Tax Ordinance), which shall provide for the imposition and collection of, for a period of ten (10) years from its effective date of October 1 st, 2026, through October 1 st, 2036, certain local-option non-property taxes as follows:

A four percent (4%) lodging occupancy charge on receipts from all short-term rental (30 days or less) charges for lodging rentals for hotel-motel rooms, condominiums, tourist homes, vacation rentals, campgrounds, recreational vehicle parking spaces, or any other sleeping accommodation.

The non-property tax revenue derived from and collected under this Ordinance shall be used for the following purposes: Capital projects; improvement, maintenance and beautification of public infrastructure including but not limited to: pathways and/or parks, snow removal for streets, downtown sidewalks, pathways, and safe routes to school; transportation; associated land acquisition; associated equipment, visitor services and promotion; emergency services and law enforcement; direct costs to collect, administer, and enforce tax; promotion for the city, including community based organizations, except those receiving money from taxing districts; support for special events and other such activities that enhance business and provide tax revenues for the city; matching funds for grants used to further the goals of the Challis Comprehensive Plan; all of which are to be used within the City limits.
