NOTICE OF SUPPLEMENTAL LEVY ELECTION
MACKAY SCHOOL DISTRICT NO. 182 CUSTER AND BUTTE COUNTIES, IDAHO

PUBLIC NOTICE IS HEREBY GIVEN according to law and requisite action by the Board of Trustees of Mackay School District No. 182, Custer and Butte, Counties, Idaho, that a Supplemental Maintenance and Operations Levy Election will be held on Tuesday, May 19, 2026, in the Mackay School District No. 182, Custer and Butte Counties, State of Idaho, for the purpose of submitting to the qualified electors of said District their vote at precinct polling sites open 8:00 AM to 8:00 PM for the "Shall the Board of Trustees of Mackay School District No.182, Custer and Butte Counties, Idaho, be authorized and empowered to levy a Supplemental Maintenance and Operations Levy, as permitted by law in Section 33-802(3), Idaho Code for the amount of One Hundred Thousand Dollars (\$100,000.00), each year for two years for a total of Two Hundred Thousand Dollars (\$200,000.00) for the purpose of the following; \$15,000.00 for classroom supplies and textbooks, \$10,000.00 for classified salaries and benefits, \$25,000.00 for building heating and utilities costs and \$50,000.00 for athletics for the fiscal years beginning July 1, 2026 and ending June 30, 2028, resulting in an annual tax of approximately \$32.90 per one hundred thousand dollars (\$100,000) of taxable assessed value, based on current conditions. The Levy will be for the purpose of paying the following; \$15,000.00 for classroom supplies and textbooks, \$10,000.00 for classified salaries and benefits, \$25,000.00 for building heating and utilities costs and \$50,000.00 for athletics, as provided in the resolution of the Board of Trustees of Mackay School District No. 182 adopted on March 13, 2026."

Said election will be conducted pursuant to Title 34 Idaho Code.

Polls are open from 8 am to 8 pm on May 19, 2026.
